

Consent Form. Terms and Conditions.

By signing this form/ electronically ticking the box before booking, you (Service Recipient) verify that you:

- 1- have read and understood the terms and conditions, as outlined and published by Third Eye Archery (Service Provider), on www.thirdyearchery.com.
- 2- have read and familiarised yourself with the Service Description and programme curriculum and are happy with the structure and modes of communication for this 4 Week Programme/ or with the mode of feedback for the One-Off Full Form Video Assessment.
- 3- You agree to the Privacy Policy and understand how your data is handled and stored; the repercussions for non-compliance with the laws of privacy, data exchange, storage and handling, laws regarding the safety of minors.

To Summarise:

Your Service Provider obliges to:

- 1- Respect and follow Privacy Guidelines, safeguard personal information and data, as prescribed in Privacy Policy
- 2- To Provide Excellent Service and deliver all of the services as described under 'Service Description', as advertised on the website:

i.e. '4 week Training Plan Package' includes 4 Full Form Video Assessments, 4 coach feedbacks- 2 offline mode and 2 online mode, 1 '3 Months' Training Plan. To deliver the service at the timelines set by the curriculum (weekly basis), unless there is a fault in connection when arranging for online feedback sessions, during week 2 and 4- in this event 1-3 days is considered as an acceptable delay to 'set timelines' for both Service Provider and Service Recipient (this will be resolved by the Service Recipient and the Coach).

OR

- For One-Off Full Form Video Assessments, to provide offline feedback within a maximum of 7 days, depending on service traffic. For the returning Package Users (returning after the completion of a 3 months programme), One-Off Full Form Video Assessments are in online mode, unless the Service Recipient opts for offline feedback.

- 3- To act in the interest of athlete's improvement. Service Provider will never advise anything that may harm Service Recipient's integrity, physical or mental wellbeing. The Service Provider does not hold accountability for Service Recipient's training environment, pre-existing or newly acquired health conditions/or injury. It is the Service Recipients obligation to provide truthful information about their health or any conditions they may have.

You, the Service Recipient agree to/agree to follow:

- 1- Data Privacy Guidelines, as prescribed in Privacy Policy
- 2- Third Eye Archery Booking Policy, including, Service Use Policy, Site Use Policy, Intellectual Property Policy, Cancellation & Refund Policies
- 3- to commit to the programme as outlined. It is your responsibility to ensure you have the time to fully part-take in this 4 Week Training Programme. As mentioned above, for online feedback mode as prescribed for Weeks 2 and 4, 1-3 days of delay in schedule is acceptable on the account of faults in technology/loss of connection. You and your Coach will arrange for the next convenient time slot.
OR to the terms of a One-Off Full Form Video Assessment
- 4- in the event of being unable to continue with the programme, for any reason, you have the following two options: 1) to freeze your package until the expiry date – 6 months from Day 1 (Date of the 4 weeks programme start, as you chose in the calendar during booking), OR 2) to exchange the remaining sessions for One-Off Full Form Video Assessments, to the amount of remaining sessions, on your, or any other name of your choice.
- 5- provide your Service Provider with the truthful information, to the best of your knowledge, including that which you provide in your Athlete's Questionnaire.
- 6- To be held responsible for your training environment, your health and any injuries that may occur during, or after Training period (during and after the 4 week Training Programme)
- 7- You agree to exchange files and materials with your coach through sync.com
